It contains 68 minerals and trace elements, including potassium, iron, magnesium and manganese. Super Greensand[®] increases the soil's capacity to retain water and nutrients. Contrary to most potassium fertilizers, Super Greensand[®] has no additives, no salt and no chlorine.

Super Greensand[®] is organic approved and can be used by anyone on flowers, vegetables, fruits, lawn, shrubbery and trees. It is easy to apply and safe to handle.

In the United States ("U.S."), the market for lawn and garden supplies is expected to reach \$6.6 billion in 2019¹. More North Americans are growing fruits and vegetables at home. Verde is now targeting the retail market to ensure that individual consumers can also gain access to the benefits of Super Greensand[®]. Customers will have the ease of ordering online and have the product delivered direct to them for home use.
